REPORTS FROM COOPERATING AGENCIES AND GUESTS:

Commissioners - Daryl Miller stated that it is business as usual, they continue work on bridges and towers. Nothing new to report on.

NRCS

- New staff continue trainings toward certified planning
- 3 of the livestock contracts have contractors lined up and construction will start soon
- Continue working on EQIP contracts for FY23 and certifying spring practices
- Working with BCCD on paperwork partnering with ACAP funds next round of ACAP assessments
- Received email that NRCS will be offering PISP – Post-Inflationary Supplemental Payments. Eligible practices will need to be completed between January 1 to September 1, 2023. There will be no extensions of this deadline. *****The agency anticipates that the amount of cost overrun funds needed will exceed the amount of PISP cost overrun funds currently available, so when cost overrun funds run out it's over, so NO guarantees that work completed by the deadline will receive a PISP. NRCS could run out of the PISP cost overrun funds at any point.**

Commission Report – Field Representative - Rachael Fish reviewed the DEP Conservation District Field Rep Talking Points that was handed out.

CLAVERACK – Brian Zeidner spoke about the recent outages and broadband is continuing. They went to Washington DC and discussed with Legislation broadband and the supply chain and support as well as the Nuclear and Hydro plants.

May 2023 DEP Conservation District Field Rep Talking Points

2023 Growing Greener Plus Grant Round opened on April 21, 2023

Growing Greener grants are designed to improve or protect Pennsylvania's waters from nonpoint source pollution associated with agricultural activities, AMD, stormwater runoff, energy resource extraction, and streambank and shoreline degradation, while Bond Forfeiture grants are designed to address legacy mining impacts.

DEP has identified multiple priority areas for this grant solicitation. Priority areas for Growing Greener grants include projects that reduce nonpoint source pollution – especially nitrogen, phosphorous, and sediment pollution from agricultural and stormwater runoff. DEP is particularly interested in design and construction projects that implement effective Best Management Practices (BMPs) that reduce or eliminate pollutant loadings and lead to local water quality improvements.

One new priority area for Growing Greener grants include Technical Assistance projects featuring public-private partnerships and focus projects on multiple regions or statewide scale with the purpose to expedite on-the-ground, BMP implementation.

Eligible applicants include counties, municipalities, municipal authorities, county conservation districts, watershed organizations, councils of governments, educational institutions, and other authorized organizations involved in water resource restoration and protection. The maximum Growing Greener grant request amount is \$500,000.

New this year, applicants may apply for Stormwater Management Planning (Act 167) grants under the Storm Water Management Act (Act of Oct. 4, 1978, P.L. 864, No. 167). The primary focus of the Act 167 grants is the preparation or revision of Act 167 Plans by counties.

Model My Watershed Virtual Training - Mark your calendars! DEP's Watershed Support Section and Drexel University will be hosting three, two-part, webinar trainings on Model My Watershed. The training, taught by Dr. Barry Evans of Drexel University, will go over all of the functions of Model My Watershed during the two half-day sessions (approximately 3 hours) to help attendees effectively use watershed modeling for future projects.

This training is mandatory for all Conservation District Watershed Specialists. An official invite will be sent out to districts in the near future.

This training has been broken into three different events in order to allow for a more interactive atmosphere. The training dates for each region are:

- Northwest and Southwest regions: Morning of June 12 and 15
- Northcentral and Southcentral regions: Morning of June 26 and 29
- Northeast and Southeast regions: Morning of July 31 and August 3

Chapter 102 Program

Chapter 102 Basic Technical Training - The Chapter 102 Program, with help from PACD, is offering a Chapter 102 Basic Technical Training, a valuable training for new Chapter 102 staff to provide guidance on program details. Topics at the training include; Chapter 102 Application and Permits, Reviewing a plan and preparing for a site visit, How to Conduct yourself in the Field, E-Permit Reviews, **Field Exercises** – Site Inspection of Active Earth Disturbance and Final NOT Inspection, Lessons learned from Field Exercises, Panel Discussion – District Challenges. This training is available to new Chapter 102 staff, existing Chapter 102 staff who would like a refresher on program details, and CD managers. The training will take place May 23-26 at the Red Lion Hotel Harrisburg/Hershey. Registration, training agenda, lodging details, etc. can be found on Clean Water Academy, [Course: Chapter 102 Basic Technical Training \(2023\) \(remote-learner.net\)](#). After logging into CWA, click on the PACD Events and Training Calendar. Participants should also review prerequisite work and review items recommended and required for classroom and field work.

Chapter 102 Listening Sessions - The Bureau of Clean Water (BCW) has started scheduling Chapter 102 listening sessions with the conservation districts again and intend to hold them as a matter of “routine communication” moving forward. BCW hopes to hear district accomplishments as well as concerns during these sessions. They will be held once a month virtually for approximately 2 hours at a time and will contain a group of 2-3 conservation districts and DEP staff. We intend to schedule these calls 2-3 months in advance, so districts should be on the lookout for that invitation over the next year.

Practice Keeper Enhancements Coming in May

Several updates and enhancements will be coming to PracticeKeeper in May.

- The BMP Expiration Report and Upcoming Status Review Report are two new reports that will be coming available.
- The Attachment-G Report, Level 2 Plan Approval Report, and CBP 23 Report will be receiving updates.

These new and updated reports can be expected in the month of May with more enhancements related to Data Explorer, Spatial Data Export, Copy BMP Tool in the Conservation Planning Module, and others will be complete in May or June. A more detailed announcement will be sent to the PracticeKeeper Admins in each CCD and the Conservation District List Serve once the enhancements have been released to production.

Agriculture Compliance Implementation Poll

The Agriculture Compliance Section is conducting a poll to gain insight on the implementation of Agriculture Compliance across the state. This poll is targeted to 102 Delegated County Conservation District's across the Commonwealth. The main goal is to gain knowledge of County Conservation District's complaint response, inspection procedures, and education and outreach regarding agriculture erosion and sediment control. The information gathered from the poll will assist DEP as the DEP Agriculture Compliance Section as we strive to provide guidance for consistent execution of Agriculture-related activities across the Commonwealth. The program intends to distribute the poll in May.

PA Agricultural Conservation Assistance Program (ACAP)

As of March 31, 2023, 65 districts have signed and sent in their agreements. As the SCC has finalized the signature process for the delegation agreements, initial allocations have been processed. Many district should have already received their first allocation and other should be arriving in the district accounts in the near future.

SCC has developed a webpage on the PDA website where they plan to keep updated ACAP information and webinar recordings. The webpage currently has the ACAP Guidelines, SCC BMP List and a draft ACAP Application. Also posted is the past recorded webinars. On April 12, 2023, SCC hosted their ACAP update webinar for CD's. SCC staff provided an update on ACAP GIS, staffing and technical assistance. Many policy questions were raised by districts and will be added to the Q&A document. Roughly 80 attended the webinar.

SCC staff intend to continue monthly webinars for all District managers for the foreseeable future.

ACAP Workgroups Continue

The ACAP Advisory Workgroup reviews draft documents and provides input on new policies in the program. The ACAP Advisory Workgroup was very key in the development of the Setback Policy and will now move forward in discussions about Bidding policies.

The ACAP Center Subcommittee continues to discuss the Center and the expansion of Boot Camp Trainings. Jennifer Fetter of Penn State will be spearheading the development of the Center, which includes laying out the framework and building staff capacity. SCC plans to meet with Penn State to discuss the needs of State Engineering as well as other outputs.

The ACAP Technical Assistance Workgroup advises on the task of Trainings for Technical Assistance as well as technical support across the state. This group met on February 22nd to discuss engineering, RFPs, Job Approval Authority, Certifications for BMPs and Admin Training. With the development of the Center starting to take shape, SCC anticipates this group to reconvene to discuss the actual needs for districts state-wide on a more regular basis.

SCC has formed an Engineering Workgroup consisting of District Engineers, District Techs and SCC. This group are in discussions of the building blocks of a state run engineering program that will allow SCC to develop their own Job Approval Authority. This group is meeting every two or so weeks. The group has determined that the state does need their own system with at least one State Engineer housed or working with the new Center. Regional support is going to be key so the group continues to discuss how to regionally support the districts.

- Met with PSU and NRCS about a state Job Approval Authority system
- Budget and Scope of Work has been submitted by PSU for the Center Contract
- Center is hiring a 3rd party engineer to assist with TA
- Working with PACD to hire 5 planners regionally
- SCC plans to staff regional engineers at CD similar to the Bay Engineer design
- Discussions of pre-concurred designs for HUAP and other BMPs are taking place with CD’s
